Application & Sketch Requirements

The following must be submitted to the Town Office in advance of the hearing for public notice. Call the Town Office at 372-6926 for specific monthly deadlines.

1. A completed application
2. Fee paid in full
3. Two copies of a sketch plan

The site plan must, as applicable, include the following information:

- Names and addresses of the owner and/or his agent.
- Names of the owners of contiguous properties.
- Date, North Arrow and scale
- Property lines, with rough dimensions, and area of subject parcel.
- Proposed name or identifying title of parcel(s) and name of Town.
- Significant features such as the location of wetlands, streams, etc.
- Existing and proposed structures (indicating type), public roads, deeded rights-of-way, wells, septic systems, etc. and their size, type and location relative to property lines.
- Zoning districts
- Vicinity map, which is a map inset that shows the location of the subject property on the island.
- Parking and circulation, including access to roads.
- Designated on-site vehicular and pedestrian circulation with adequate access provided for all site amenities.
- The location of all exterior storage areas for materials, machinery and/or vehicles.
- The location, dimensions and detail of signage, displays and advertisements.
- Any fuel or hazardous waste storage areas.

The applicant and all adjacent property owners will be notified in writing of the date, time and place of the warned hearing.
