New Waterlines or Services

All new waterlines are required to meet the following conditions:


1) A drawing of service plans for the project must be submitted to the Town Office with a Water Service Agreement form.

Plans will include:

- I. Pipe size, type of pipe, and pressure rating.
- II. Location of gate valves, curb stops, blow offs (with size) and thrust blocks.
- III. Location of property lines, roads and applicable right of ways or easements. If the new main or service is on private property a legal easement must be deeded to the Town of North Hero.
- IV. Name of overseeing engineer or a request to be overseen by the North Hero Water Department Operator.
- 2) Projects involving the installation of new water main lines will require a state permit.
- 3) Project must be overseen by an engineer and/or the North Hero Water Department Operator.
- 4) All costs including plans, installation, pressure test, a bacteria test and applicable North Hero Water Department Operator time (\$75.00 an hour) will be borne by project owner(s).
- 5) A pressure test demonstrating appropriate pressure will be performed by an engineer or the North Hero Water Department Operator
- 6) A bacteria test must be performed and passed by an engineer or the North Hero Water Department Operator. The water test results will be submitted to the North Hero Water Department Operator.
- 7) Before water can be turned on:
 - a) The North Hero Water Department Operator will perform an inspection of the installed line to verify compliance with Water Department Policy.
 - b) Bacteria and pressure test results must be satisfactory.
 - c) Paper work verifying all of the above conditions have been met must be submitted to the North Hero Water Department Operator.

TYPICAL LINE SCHEMATIC YOUR WATER SERVICE MUST HAVE BEFORE THE WATER CAN BE TURNED ON

Note: Your private plumber cannot turn the water on!



Note:

- 1. New water mains will be C-900 PVC or PSI P.E.
- 2. New gate valves will be resilient wedge ANSI/AWWA C509 (open left)
- 3. New service connection will be double strap saddle S.S. type with C.C. threads
- 4. Curb stops located at edge of R.O.W. will be ¼ turn ball valve (non-draining)

Property Owner/Contractor Installation Requirement as of 8/27/2018

Effective immediately, all non-metallic (PVC, HDPE, etc.) lines installed are required to have tracer wire.

This includes new water mains (town or private), service lines, and other situations as deemed necessary.

- Water mains are required to have tracer wire from valve box to valve box, when possible.
- Service lines are required to have tracing wire installed from the corporation to the curb box and from the curb box to the ball valve at the house.

The tracing wire should be a #12 AWG Copper Clad Steel with a HDPE coating.

Town of North Hero Water Service Agreement

Terms and conditions:

- A. Construction of the proposed water service or water main is contingent upon receipt of applicable hook on fees and, if required, State approval of design of construction.
- B. Water service to any particular property is not guaranteed by this agreement. Any such decisions of serviceability shall be made exclusively by the North Hero Water Board.
- C. The water user is required to arrange and pay for the installation and connection of all service piping from the Town water main to the site of intended use. All corresponding instillation costs are to be borne by the owner.
- D. Water shall be provided through a single service line or water main only for residential or commercial uses. Additional uses or a change in use shall result in revision of this contract and/or a change in fees.
- E. Water service shall be provided subject to the conditions of the Rules and Regulations as promulgated from time to time by the North Hero Water Board.
- F. In the case of connections to existing systems, such systems shall be upgraded to Town standards, prior to service being initiated by the Town. If such systems are not upgraded and do not meet Town standards the Town will not supply water. All maintenance and operational costs of privately owned lines will be borne by those served.
